Review and recommendation to approve an increase in medical premiums with no change in medical benefit schedules; BREC Commission to pay 85% of the employee HMO plan premium and 60% of the dependent premium. This amount will be applied to the PPO Plan if the employee wishes to upgrade. Non-participants of the EmployeeWellness Program will be subject to a premium increase of \$20 per pay period or \$520 annually.(See Proposed 2022 Schedule of Benefits and Premium table.)

- D. Review and recommendation to approve the 2022 ASO Administrative ServicesAgreement Claims Administration Fee with no increase in administrative fees for medical and pharmacy.
- E. Review and recommendation to approve the 2022 Employer Paid Group Term Life Insurance with Blue Cross Blue Shield of Louisiana and administered by Equitable with a 15% increase in premium. (See attached.) Review and recommendation to approve the 2022 Voluntary Life with Blue Cross Blue Shield of Louisiana and administered by Equitable with a flat renewal. (Note: Rates are determined by age.)
