The Recreation and Park Commission for the Parish of East Baton Rouge (BREC) is soliciting Request for Qualifications (RFQ) from Architectural, Landscape Architectural, and Engineering firms for professional services related to planning master planning, design, abatement, bid advertisement/award, construction documentation, and construction administration for upcoming projects.

BREC's building program may include project types such as new or renovated or repurposed recreation centers, maintenance buildings, athletic/sports facilities, greenway trails, community parks, neighborhood parks, conservation areas, cultural/historic areas, support areas, parking, fishing areas, and special use facilities (dog parks, golf course facilities, horse activity center, etc.), as well as modifications, renovations and enhancements to existing recreation, park and other special use facilities. Modifications to existing buildings may include structural modifications, re-roofing, facility expansion and other related activities.

It is the intention of BREC to contract with a number of professional service firms for planned construction projects. These firms may be selected for a single project or for multiple projects through the end of 2024. BREC will pre-qualify firms based on qualifications and experience shown in their response and criteria specified in this RFQ. Consultants selected will be considered the lead consultant and will be responsible, as part of the project and project fee, for contracting with typically needed sub consultants. A short description of projects is listed in this RFQ under section 8.

Firms will be selected by a BREC Professional Services Selection Committee. To keep a balanced approach, please do not contact the Professional Services Selection Committee or BREC staff for additional information in regard to these projects.



REQUIREMENTS FOR SUBMISSION

1. Firm Description

Provide a short overview of your firm's history. Describe how your firm typically manages multiple projects while meeting all client deadlines and commitments. Please indicate if your firm is officially recognized as a small or disadvantaged business and provide written evidence of DBE status. Provide a physical address for your firm. Lead firms must have full time staff properly licensed for the work.

2. Staff

Identify principals and key staff members within the firm who would typically be assigned to a project such as the types checked in Item 8, Projects Being Considered for Professional Services. For each person listed, include a resume, description of typical responsibilities, years of experience (total experience as well as experience with current firm), and list of specific projects worked on, noting whether performed with current firm or previous firms. List Louisiana licensed staff with clear indication of the type of license.

3. Experience

List the total number of projects undertaken by your firm that are representative of the project types you have checked in Item 8, Projects Being Considered for Professional Services. For each project type you have checked, you should indicate applicable projects for which your firm has completed professional services. For each listed project include name, location, scope, construction cost, graphics or photographs that illustrate the project and a knowledgeable contact person (name, current address, email address and current telephone number). Additionally, the staff that worked on the project is to be included with their roles. It should be noted if the work was done by staff while not part of the current firm. Limited graphics and written material for the projects is expected. The material may include representative samples of construction drawings, photographs of completed projects, colored renderings, and other graphics that you believe will help demonstrate your firm's capabilities and experience.

4. Additional Samples (optional)

You may provide additional graphical and written information regarding your qualifications that you believe are appropriate for consideration for Parks and Recreation related work.

5. Criteria for Selection

Experience relevant to the particular projects, staff qualifications, previous experience with BREC, currently working for BREC, and familiarity with a particular project will be considered in the selection process along with other considerations. It is the intent of BREC to engage a wide range of firms in the parish. BREC works only in East Baton Rouge Parish and is supported by taxes from East Baton Rouge Parish. Firms residing in East Baton Rouge Parish will be given additional consideration unless otherwise noted in this document.

6. Agreement

Although the professional service firms selected under this RFQ shall be considered as being pre-qualified to provide consulting services for a selected number of BREC projects, BREC makes no representation as to the frequency, number or types of projects, if any, which will be assigned to a given firm. Some projects will be contingent on future funding which may not become available. The pre-qualified firms will each agree to perform their professional services in accordance with the BREC fee curve shown below:

Curve Calculator = "CC"

Fee Computation: Fee % = 50.00

Note for renovation projects requiring greater than ordinary work a renovation factor of 1.05 to 1.2 can be applied, depending upon degree of difficulty. Additionally, simple projects, such as parking lots can have a simplicity factor up to .8 applied. The CC provides an interim fee, which can be adjusted for actual construction costs. Also note that some projects require less than full services such as a project that has been master planned and plans that have been taken through design development. A reduced fee can be expected on these projects.

As an example, a fee for a \$500,000 project with no mitigating factors would be:

Note that in limited cases where the Fee Curve may not be appropriate, BREC may require additional information, including requesting detailed proposals on specific projects. Though a firm may be selected through this process for a particular project, selection does not guarantee that BREC will actually contract for a particular project. Anticipated projects may be cancelled or delayed for reasons such as new initiatives or unavailable funding.

For any contract with BREC for professional design services, required documents include a contract agreement, RS 38:2224 Affidavit, proof of insurance, Form W-9, and a corporate resolution if applicable. All vendors contracting with BREC must be registered in good standing with the Louisiana Secretary of State.

7. Submission

It is preferred that material be submitted in 8.5"x11" format following the order of this request. Graphic examples of projects can include 11"x17" or other sizes. Submittals are due by 4:00 pm CT on Monday, May 17, 2021 at the address above. If submittals are mailed or shipped, they must be done in a manner that will meet this timeline.

Objections to any provisions in this request must be identified in writing in the Request for Qualifications submittal. NO RESPONSE WILL SIGNIFY THAT THE AGREEMENT IS ACCEPTABLE AS WRITTEN.
